



CONCISE TERMS AND CONDITIONS FOR JOB BAGS / PRO's – CONNECTGROUP

The quotation is valid for 15 days. Once-off fees require a 50% deposit and the balance due on completion of the project. Billing terms are 30 days from invoice from MegaVision Media, unless otherwise negotiated and agreed upon by all parties. If any payment is greater than 30 days past due, the service or Program can be suspended until payment is received, at ConnectGroup's discretion.

Signature of the quote or any other written form of acceptance shall constitute the acceptance of ConnectGroup / MegaVision Media's terms. A complete set of terms may be requested by the client.

FULL TERMS AND CONDITIONS – CONNECTGROUP

1. ConnectGroup provides three main technology solutions to the market; ConnectFMCG, ConnectHOTEL and ConnectLIVING. These platforms will hereby be referred to as the "Program" or "Programs".
2. Each product has its own rate card and payment structures which are presented and disclosed to the Client. This will hereby be referred to as "License Fees" or "Fees".
3. New clients will be required to complete onboarding forms and all invoicing will come from MegaVision Media (Pty) Ltd.
4. All Programs billing terms are 30 days from invoice from MegaVision Media . Unless otherwise negotiated and agreed upon by all parties.
5. If any payment is greater than 30 days past due, the service or Program can be suspended until payment is received, at ConnectGroup's discretion.
6. You may only use the Service and Licensed Software if you have paid all License Fees due to MegaVision Media. All pricing terms are confidential, and you agree not to disclose them to any third party.
7. Any new requests, customisations and specialised requirements will be costed out and quoted for separately. A 50% deposit will be required upfront and the remaining 50% deposit will be paid on completion of the scope of work.
8. Except as expressly permitted by ConnectGroup, the Program may not be exploited for any commercial purpose, may not be reproduced, distributed, republished, displayed or transmitted.
9. ConnectGroup is owned by MegaVision Media in its entirety and all intellectual property remains the product of MegaVision Media which is licensed out non-exclusively to clients in South Africa and abroad.



10. Signature of the quote or any other written form of acceptance shall constitute the acceptance of ConnectGroup / MegaVision Media's terms.
11. An automatic renewal of the contract will take place at the beginning of each month. Hence, the sign-off will not only be applicable to the first month, but up to 12 months, until a 30-day notice has been given to terminate a ConnectLIVING and ConnectHOTEL contract and 60-day or 90-day notice to a ConnectFMCG contract, unless otherwise negotiated and agreed upon separately by all parties.
12. It is solely the Client's responsibility to evaluate the accuracy, completeness, reliability, security, and validity of all information presented on, or accessed through, the Program.
13. Client is to supply hardware and data required to operate the programs. The ConnectGroup does not offer this service. The Client is also responsible for ensuring that the devices mentioned are insured.
14. The ConnectGroup may immediately terminate a contract for Client's breach of terms, upon written notice.
15. Upon termination of a contract for any reason, any amounts owed to ConnectGroup / MegaVision Media before such termination will be immediately due and payable. Furthermore, all rights granted to Client will immediately cease to exist, and all Services, Programs and Licensed Software provided by ConnectGroup may cease functioning, the precise timing of which shall be determined at ConnectGroup's sole discretion within the confines of what is fair and deserved. If a subscriber elects to terminate a contract, no portion of the Fees will be refunded or excused.
16. All the data we receive from the Client and all the data we record on our Programs are stored on ISO 27001:2013 compliant servers and are POPI (Protection of Personal Information Act) compliant. The ConnectGroup / MegaVision Media do not use this data for any purpose such as advertising or selling to third parties for the above-mentioned purposes.
